Isakson & Roe Update: Verification of Enrollment (Section 1010)

- **STARTING DECEMBER 17, 2021**
 In order for Post-9/11 (Chapter 33) beneficiaries to continue collecting a monthly housing allowance (BAH), a new monthly verification system has been created to certify your enrollment status monthly with the VA.
 ⇒ **Opt-in for text or phone verification, call 1-888-442-4551**
 → If a student fails to verify his/her enrollment for two consecutive months, the monthly stipend will be suspended.

Student Responsibilities/Acknowledgements
